After careful examination of the proposals received vide reference 5th cited and recommendations of the Inspecting Officer in the letter 6th cited, and conditions prescribed in Govt. orders read above, the competent authority i.e, the District Educational Officer, Krishna hereby accords **Provisional Recognition** for classes **I to VII** English Medium for the period from **2014-2015 to 2023-2024** in respect of "**HEAL School(EM), Narsingapalem(V), Agiripalli(M), Krishna District**" without aid subject to the following conditions:

- 7) that the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.
- 8) that the list of Governing Body shall be furnished to the District Educational Officer every year.

- 9) that the pay structure/fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
- 10) that all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be complied with.
- 11) that the school shall not be closed without giving notice both to the parents/District Educational Officer and competent authority at least 6 months before.
- 12) that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13) that the society shall be submit proposals for Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
- 14) that the management of the school should renewal of Fire NOC every Year without fail.

Previously opening permission has been accorded to the classes VIII to X (E.M) to HEAL School (EM), Narisingapalem, Agiripalli Mandal, Krishna District during the years from 2016 to 2017 in Proceedings Rc.No 2875//A2/2017 Dated.17.01.2017 of the Regional Joint Director of School Education, Kakinada in the reference 4th read above. The Correspondent has submitted the application for Provisional of Recognition for the classes VIII to X (E.M) in the school for the years from 2016 2017 to 2025-2026 in the reference 6th read above. The District Educational Officer, Krishna, Machilipatnam has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby accords for Provisional Recognition for a period of 10 (TEN) years i.e., for the academic years from 2016-2017 to 2025-2026 for the classes VIII to X (E.M) as recommended by the Deputy Educational Officer, Nuzvid, and the District Educational Officer, Krishna, Machilipatnam subject to fulfillment of the following conditions in HEAL School (EM), Narisingapalem, Agiripalli Mandal, Krishna District .

1. That the society shall abide to the rules and regulations made in the Government order 1st and 2nd cited above.
2. That the society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking Water facilities, Furniture, Library, Laboratory Equipment, Play Field required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.
3. That the society shall apply for recognition immediately duly fulfilling the conditions.
4. That the permission accorded is restricted to this year only and it is not valid for subsequent academic year.
5. That this permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded to HEAL School (EM), Narisingapalem,(Vi) Agiripalli Mandal, Krishna District and no other society or body can open a school on their behalf of.
7. The permission is accorded to open the school in which the premises of the locality and there shall not be change in the premises or locality.
8. The society shall provide the necessary material even if it costs more than the deposit amount.
9. Proper and adequate sanitation facility shall be provided for students especially for girl students.
10. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
11. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
12. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
13. The school shall have first aid kit and the teachers shall be trained in first aid.
14. The management should fulfill all the conditions as per G.O.Ms.No.41 Education For All (HEAL) Dated.11.5.2006 at the time of applying for Provisional Recognition.
